Please take notice that the Le Sueur and Rice County Boards of Commissioners, Joint Drainage Authority for Le Sueur/Rice Judicial Ditch (JD) 63, upon the Petition of the Minnesota Commissioner of Transportation will hold a hearing on Friday, March 29th at 10:00 a.m. at the Le Sueur County Courthouse, to consider the Commissioner's request to modify a portion of JD 63.

The Commissioner's and Drainage Authority's reports regarding the impact of the proposed modification are filed with the Le Sueur County Auditor and are available for review. The action involves modification (enlargement and replacement) of the culvert under Trunk Highway 99 between sections 25 and 36 of Montgomery Township.
