

**Minutes of Le Sueur County Board of Commissioners Meeting  
Tuesday, April 27, 2010**

The Le Sueur County Board of Commissioners met in regular session on Tuesday, April 27, 2010 at 9:30 a.m. in the Courthouse at Le Center, Minnesota. Those members present were: Joe Doherty, John Grimm, Robert Culhane, William Stangler, and Joe Connolly, Chairman. Also present were Brent Christian and Carol Blaschko.

On motion by Culhane, seconded by Doherty, the Board unanimously approved the amended agenda for the business of the day.

On motion by Grimm, seconded by Culhane, the Board unanimously approved the consent agenda:

- Approved the April 20, 2010 County Board Minutes

At 9:35 a.m. the Board convened a Public Hearing for the purpose of taking public comments on amending the Le Sueur County Subdivision Ordinance, Section 4; Subdivision 4.12 Public Sites and Open Space, C and amending Le Sueur County Zoning Ordinance, repealing and replacing Section 16, Animal Feedlot and Manure Management. Kathy Brockway, Planning & Zoning Administrator and Amy Beatty, Environmental Program Specialist appeared before the Board to discuss the proposed ordinance changes. Comments and questions about the changes were received from the audience. The public hearing was closed at 10:20 a.m.

On motion by Grimm, seconded by Stangler and approved via roll call vote 4-1, with Commissioners Doherty, Stangler, Grimm and Connolly voting Aye and Commissioner Culhane voting Nay, the amendment of the Le Sueur County Subdivision Ordinance, Section 4; Subdivision 4.12 Public Sites and Open Space, C were adopted.

On motion by Grimm, seconded by Stangler the request to amend Le Sueur County ordinance, repealing and replacing Section 16, Animal Feedlot and Manure Management was tabled until a further date.

Kathy Brockway, Planning and Zoning Administrator appeared before the Board with the following request for action:

On motion by Stangler, seconded by Grimm and approved via roll call vote 4-1, with Commissioner Doherty, Stangler, Grimm and Connolly voting Aye and Commissioner Culhane voting Nay, the Board amended an existing Conditional Use Permit (#29002) of LE SUEUR COUNTY PARKS DEPARTMENT (APPLICANT); LE SUEUR COUNTY (OWNER) to allow applicant to operate a 29-campsite outdoor recreation area (campground) to allow over-night camping in the Lake Washington Park in an Agricultural "A" District and Special Protection "SP" District on a Recreational Development "RD" lake, Lake Washington. Property is located in the North ½, Section 12, Kasota Township The County Park Department agrees to continue to work with the Le Sueur County Sanitarian.

On motion by Stangler, seconded by Grimm and approved the Board authorized the Chair to sign the Home and Community Based contracts between Le Sueur County and the following:

- Horizon Place, Inc of Le Center for Assisted Living  
contract dates 5-1-10 to 6-30-11
- Le Sueur County Public Health for Home Care Services  
contract dates 7-1-09 to 6-30-11

Cindy Westerhouse, Personnel Coordinator, came before the Board with one recommendation.

On motion by Stangler, seconded by Culhane and unanimously approved the Board granted permanent status to Christopher Schoenstedt, full-time Financial Worker in Human Services, effective April 26, 2010.

Cindy Westerhouse, Personnel, Amber Struck, Public Health and Elisa O'Malley, Public Health, all part of the Wellness Committee, came before the Board to invite them to join the Nutrition Challenge that the Wellness Committee is currently putting on.

On motion by Culhane, seconded by Stangler and approved, the Board approved the on & off sale 3.2 beer license of Jerry Miller dba Best Point Resort.

On motion by Culhane, seconded by Grimm and approved, the Board adjourned until Tuesday, May 4, 2010 at 9:30 a.m.
