

**Minutes of Le Sueur County Board of Commissioners Meeting
August 24, 2021**

The Le Sueur County Board of Commissioners met in regular session on Tuesday, August 24, 2021 at 9:00 a.m. in the Government Center at Le Center, Minnesota. Those members present were: Dave Gliszinski, John King, Danny O’Keefe, Steve Rohlfing and Lance Wetzel. Also present were Joe Martin, Brent Christian and Pam Herrmann.

On motion by O’Keefe, seconded by Wetzel, the Board unanimously approved the agenda for the business of the day.

On motion by King, seconded by Gliszinski, the Board unanimously approved the consent agenda:

Aaron Stubbs, Planning & Zoning Administrator came before the Board with two items for approval.

On motion by Gliszinski, seconded by King, and approved via roll call vote 5 to 0, the Board granted an After-The-Fact Conditional Use Permit to TOM WETZELL, CLEVELAND, MN, (APPLICANT/Owner) to allow grading, excavating, and filling of more than 10 cubic yards in the Shore Impact Zone and more than 50 cubic yards on a lot in a Recreational Residential “RR” Shoreland District of Lake Jefferson, a Recreational Development “RD” lake. The property is described as Lots 20 & 21 Edgewater Terrace, located in Section 3, Cleveland Township. The application was approved as presented and findings are on file at the Planning & Zoning office.

On motion by Wetzel, seconded by O’Keefe and approved via roll call vote 5 to 0, the Board granted a Conditional Use Permit to TODD & KARI POTTINGER, WATERVILLE, MN, (APPLICANT/OWNER) to allow the applicant to cut in the bluff for the construction of stairs in a Recreational Residential “RR” Shoreland District of Lake Tetonka, a Recreational Development “RD” Lake. The property is described as Lot 2 of the Hidden Hills CIC #24, located in Section 19, Waterville Township. The application was approved as presented and findings are on file at the Planning & Zoning office.

On motion by Wetzel, seconded by O'Keefe, the Board unanimously approved the recommendation to accept the retirement request from Sue Rynda, Human Services Director, effective December 31, 2021.

On motion by King, seconded by Wetzel, the Board unanimously approved the recommendation to accept Gallagher's market study data results.

On motion by O'Keefe, seconded by King, the Board approved the recommendation to keep the SAFE Evaluation Program in place for the County's classification program.

Ann Traxler, Emergency Management came before the Board with one item for approval.

On motion by Wetzel, seconded by Gliszinski, the Board unanimously approved the Grant Contract Agreement between MN Department of Public Safety Homeland Security and Emergency Management Division and Le Sueur County for \$6,000.00 for 2022-2023 Radiological Emergency Preparedness.

Tyler Luethje, Parks Director came before the Board with one item for approval.

On motion by Wetzel, seconded by King, the Board unanimously approved the quote for \$7,000.00 from Always There Heat & Air, Inc. for the HVAC upgrade at Lake Washington Regional Park and Campground Community Building.

Holly Kalbus, Environmental Resources Specialist came before the Board with a couple items for approval.

On motion by King, seconded by O'Keefe, the Board unanimously approved the request to utilize County Gravel Tax funds for a shoreland restoration project for up to \$5,000 for Christine Rotthoff of Elysian.

On motion by Wetzel, seconded by Gliszinski, the Board unanimously approved the Stantec Consulting Services Professional Services Agreement with Le Sueur County to complete the Volney, Gorman, and Cordova Septic Inventory Project.

Joe Martin, County Administrator came before the Board with two items for approval.

On motion by Wetzel, seconded by Gliszinski, the Board approved the additional project fees for Bolton & Menk for the West Jefferson Sewer District 4 to 0 with Rohlfing abstaining from vote.

On motion by O'Keefe, seconded by Wetzel, the Board unanimously approved the Ehlers proposal to provide consulting services to Le Sueur County with respect to the American Rescue Plan Act (ARPA) and Local Fiscal Recovery (LFR) Funds.

Dani Blaschko, Auditor/Treasurer/Ditch Manager came before the Board with a few items.

On motion by Wetzel, seconded by Gliszinski, the Board unanimously approved the CD41 Contractor's Pay Application #1 for Payment to Selly Excavating, Inc. for \$115,195.95.

On motion by King, seconded by O'Keefe, the Board unanimously approved the CD61 Contractor's Pay Application #1 for Payment to Selly Excavating, Inc. for \$4,718.08.

On motion by O'Keefe, seconded by Wetzel, the Board unanimously approved the CD65 Ditch lien at 3.4%, 4% Interest, to be spread over 10 years beginning with taxes payable in 2022. The minimum assessment will be \$10 and any assessments that are \$250 or less will be payable in one installment.

There is one landowner on Le Sueur/Rice JD54 refusing to allow contractor on land for tree removal. Dani will be following up with John Kolb, our attorney.
