

**Minutes of Le Sueur County Board of Commissioners Meeting -  
January 24, 2023**

The Le Sueur County Board of Commissioners met in regular session on Tuesday, January 24, 2023 at 9:00 a.m. in the Government Center at Le Center, Minnesota. Those members present were Dave Gliszinski, John King, Danny O’Keefe, David Preisler and Steve Rohlffing. Also present were Joe Martin and Brent Christian.

On motion by O’Keefe, seconded by Preisler, the Board unanimously approved the agenda for the business of the day.

On motion by Rohlffing, seconded by Gliszinski, the Board unanimously approved the consent agenda:

Dave Tiegs, County Engineer came before the Board with three items for approval.

On motion by Preisler, seconded by Rohlffing, the Board unanimously approved the purchase of two 2024 Mack tandem truck chassis for \$287,285.06.

On motion by O’Keefe, seconded by Gliszinski, the Board unanimously approved the purchase of two Towmaster plow bodies for \$330,774.00.

On motion by O’Keefe, seconded by Preisler, the Board unanimously approved the final payment for 2022 CSAH 3 and CSAH 26 bituminous project contract to Wm. Mueller & Sons of Hamburg, MN for \$205,068.85.

Mike Schultz, SWCD District Manager, came before the Board with two items for approval.

On motion by Rohlffing, seconded by Preisler, the Board unanimously approved the Additional Support for Ditch Inspections – Professional Services Contract between Le Sueur County and Le Sueur County Soil and Water Conservation District from January 1, 2023 to December 31, 2023.

On motion by Gliszinski, seconded by O’Keefe, the Board unanimously approved the 2023 Le Sueur County Ditch Specialist Budget Proposal with 2023 Riparian Aid Allocation of \$47,625 and 2023 County Ditch Allocation of \$47,625 for a total position cost of \$95,247.76.

On motion by O’Keefe, seconded by Rohlffing, the Board unanimously granted regular status to Payton Schlueter, full time Eligibility Worker in Human Services, effective December 28, 2022.

On motion by Gliszinski, seconded by O’Keefe, the Board unanimously granted regular status to Jason Moran, full time Chief Deputy County Attorney in the County Attorney’s Office, effective January 18, 2023.

On motion by Preisler, seconded by Rohlffing, the Board unanimously granted regular status to David Perry, part time Correctional Officer in the Sheriff’s Office, effective January 19, 2023.

On motion by Preisler, seconded by O’Keefe, the Board unanimously approved the MOU between Le Sueur County and Teamsters Local No. 320 Correctional Officers/Dispatch and Deputies bargaining unit. This MOU is to correct the contract language addressing the excess vacation hours depositing into the Minnesota State Retirement System Health Care Savings Plan. This is reflective of our current process.

On motion by O’Keefe, seconded by Rohlffing, the Board unanimously approved the MOU between Le Sueur County and International Union of Operating Engineers Local No. 49 bargaining unit. This MOU is to correct the contract language addressing the excess vacation hours depositing into the Minnesota State Retirement System Health Care Savings Plan. This is reflective of our current process.
