February 21, 2023**

The Le Sueur County Board of Commissioners met in regular session on Tuesday, February 21, 2023 at 9:00 a.m. in the Government Center at Le Center, Minnesota. Those members present were Dave Gliszinski, John King, Danny O’Keefe, David Preisler and Steve Rohlfling. Also present were Joe Martin, Brent Christian and Pam Herrmann.

On motion by Rohlfling, seconded by O’Keefe, the Board unanimously approved the agenda for the business of the day.

On motion by O’Keefe, seconded by Preisler, the Board unanimously approved the consent agenda:

Laura Stang Drug Court Coordinator and Judge Goggins appeared before the Board with one item for approval.

On motion by O’Keefe, seconded by Preisler, the Board unanimously approved the request to apply for an Enhancement Grant through the Federal Government to be used for the proposed implementation of a merged Le Sueur and Sibley County Treatment Court to assist with startup costs, state and national training programs, enhanced drug testing, increased technology to monitor supervision for more accountability, and to maintain consistent peer recovery support services.

Theresa Kubes, Human Resources Director came before the Board with two items for approval.
