

Minutes of Le Sueur County Board of Commissioners Meeting September 3, 2019

The Le Sueur County Board of Commissioners met in regular session on Tuesday, September 3, 2019 at 9:00 a.m. in the Courthouse at Le Center, Minnesota. Those members present were: John King, Dave Gliszinski, Steve Rohlffing and Danny O'Keefe. Lance Wetzel was excused. Also present were County Administrator Darrell Pettis and County Attorney Brent Christian.

On motion by O'Keefe, seconded by Rohlffing and unanimously approved, the Board approved the amended agenda for the business of the day. Jeff Neisen, IT Director cancelled his agenda item and Josh Mankowski, P&Z Administrator was added to the agenda.
