

**Minutes of Le Sueur County Board of Commissioners Meeting  
June 28, 2022**

The Le Sueur County Board of Commissioners met in regular session on Tuesday, June 28, 2022 at 9:00 a.m. in the Government Center at Le Center, Minnesota. Those members present were: Danny O’Keefe, Steve Rohlfiing and Lance Wetzel. Dave Gliszinski and John King were absent. Also present were Joe Martin, Brent Christian and Pam Herrmann.

On motion by Wetzel, seconded by Rohlfiing, the Board unanimously approved the agenda for the business of the day.

On motion by Rohlfiing, seconded by Wetzel, the Board unanimously approved the consent agenda:

Aaron Stubbs, Planning and Zoning Administrator came before the Board with two items for approval.

On motion by Rohlfiing, seconded by Wetzel, and approved via roll call 3-0, the Board granted a Conditional Use Permit for **STEVE BOEHM, CLEVELAND, MN, (APPLICANT\OWNER)** to allow grading, excavating, and filling in the bluff impact zone in excess of 36 cubic yards to address an existing drainage issue and remove an abandoned septic drain field in a Recreational Residential “RR” District, Lake Jefferson, a Recreational Development “RD” lake. Property is located in Edgewater Terrace, Lots 29 & 30, Section 3, Cleveland Township. One condition change was amended from #3 – The proposed landscaping plastic under the river rock and the proposed pavers within the bluff should not be installed in order to help reduce impacts from stormwater runoff to the neighboring lot and also on the property. *Change “plastic” to “landscaping fabric”.*

On motion by Rohlfiing, seconded by Wetzel. and approved via roll call 3-0, the Board reviewed a possible revocation of an existing Conditional Use Permit for **LE SUEUR COUNTY ENVIRONMENTAL SERVICES, LE CENTER, MN, (APPLICANT); CHARLES & MICHELLE FENGER, BRIAN TIMM, ANDY BUYSSE, BRENT BUYSSE, (OWNER)** Beaver Dam Campground/Resort for failure to follow and comply with permit requirements and conditions in a Recreational Commercial “RC” District, German Lake, a Recreational Development “RD” lake. Property is located in Beaver Dam Subdivision, Lot 1, Block 4, and Part of Outlot 2, Auditor’s Subdivision Government Lot 1, Section 5, Elysian Township and Part of the SW 1/4 of the SW 1/4, Section 32, Cordova Township.

Tammy Stewig, Emergency Management Director came before the Board with one item for approval.

On motion by Wetzel, seconded by Rohlfiing, the Board unanimously approved to renew Preventative Maintenance Services with Ready Watt Electric for a 4-year contract on 8 Civil Defense Sirens at a cost per year of \$5640.00.

Cindy Westerhouse, Human Resources Director came before the Board with two items for approval.

On motion by Rohlfiing, seconded by Wetzel, the Board unanimously approved the recommendation to grant regular status to Tammy Dvorak, full time Registered Nurse in Public Health, effective June 28, 2022.

On motion by Wetzel, seconded by Rohlfing, the Board unanimously approved the recommendation to grant regular status to Aaron Stubbs, full time Environmental, Planning and Zoning Administrator, effective June 22, 2022.

Cindy Jirak, full time Lead Eligibility Worker in Human Services, effective July 15, 2022. Cindy has been employed with Le Sueur County since November 1984.
