

Le Sueur County Parks Board Application

The Le Sueur County Parks Board was established in 2003 and revised in 2017. The Parks Board looks to serve as an initial step in developing county parks and trails, outdoor recreation, tourism, preserving natural resources, and promoting healthy living within Le Sueur County for residents of the county and surrounding areas.

The Le Sueur County Parks Board is a seven member advisory group consisting of an appointed member from each of the counties five districts, plus two county commissioners. The Parks Board will serve as an active voice for the Le Sueur County Commissioners and Le Sueur County Parks Director. The members of the Parks Board will be directly involved in the mission, vision, future, and goals of Le Sueur County Parks, strategically developing future park lands and amenities, promoting outdoor recreation and tourism within the county, policy making, and all other governing matters of Le Sueur County Parks.

Members of the Le Sueur County Parks Board will be appointed by their county commissioner from their district and/or the Le Sueur County Parks Director. Members will serve on four year terms matching their county commissioners. Districts One and Three will expire in January 2019; Districts Two, Four and Five will expire in January 2021. Members can serve multiple terms.

This form is used to assist the Le Sueur County Parks Director and Le Sueur County Commissioners in evaluating the qualifications of applicants for appointment to the board.
