## Lake Washington Regional Park & Campground Rules, FAQ

- 1. **Campers:** Each camping party must register upon arrival at the Park with the caretakers, **before** setting up their campsite.
- 2. **Payment:** Payment, cash or check, must be sent in within 7 days of reservation or reservation will be cancelled. There are no refunds.
- 3. **Check out** is at 2:00pm.
- 4. **Quiet Time:** In camping areas, the hours between 10:00pm and 8:00am are for outdoor solitude, and it shall be unlawful to make noise at a level above that of a quiet conversation.
- 5. **Dump Station:** Is to be used only by campground users. The following <u>items are not allowed in the</u> <u>dump station:</u> sanitary napkins or tampons, diapers, glass, metal, seafood shells, goldfish, rock, kitty litter, socks, rags, cloth, plastic objects, toys, utinsels, explosives, flammable material, lubricating oil and grease, strong chemicals, gasoline.
- 6. **Boat Ramp:** There is not a boat ramp within the park. The DNR maintains two accesses on Lake Washington that are both within 2 miles of the park. 5516 N Shore Ct, Madison Lake. 1398 Lake Washington Access Rd, Kasota, MN.
- 7. **Fish Cleaning:** Please do not dispose of fish parts in the bath/shower house, campground dumpster, or dump station.

## Le Sueur County Ordinances Related to camping:

- 1. **Age limit:** No one under the age of 18 will be allowed to camp unless accompanied by and in the presence of a parent or guardian.
- 2. **Campfires:** Campfires are allowed in campfire rings only. All campfires must be extinguished by 1:00am. Fire rings cannot be moved. Wood must be purchased at the park or campground, purchased from a Minnesota DNR approved firewood vendor within 100 miles of the park or campground, or cut from non-ash trees within Le Sueur County. Do not burn any lumber, pallets, wood, boards, or any other materials that is not firewood.
- 3. **Park Hours:** Park is open to public from 6:00am to 10:00pm. Campground is open to the public and guests from 8:00am to 10:00pm. Anyone **not** camping must leave by 10:00pm
- 4. Fireworks or other explosives: Per county ordinance, fireworks and explosives are banned.
- 5. **Length of stay:** Seven days is the maximum stay.
- 6. **Alcohol:** Glass beverage containers and beer in containers larger than 1.75L are **not** allowed. No kegs allowed. It is against the law to possess drugs.
- Golf Carts, ATVs and other motorized vehicles: Per county ordinance, they are not allowed in the park or campground.
- 8. **Pets:** Pets shall be on a six foot leash at all times. Please pickup and dispose of your pets waste. Do not tether any pets to a tree or other plants or leave unattended in the campground.
- 9. **Campsite:** One tent may be added per campsite if it does not interfere with nearby guests. You may not have more than 6 guests per campsite unless from the same household.
- 10. **Tobacco:** Only permitted at individual campsites and parking lot.
- 11. **Facilities & Amenities:** A person may use a shelter or fire pit during daytime park hours if the facility or area is not currently reserved, but they must leave the area immediately when the reservation time period begins or when asked to by a designated employee.
